Rick Taylor presented a discussion of the FYE 2016 lodging tax receipts and presented the financial reports, including the current Claims Docket and budget. He reported that the year-to-date lodging tax revenue was running 3.4% above the same period of the prior year. Upon motion made by Cathie Price and duly seconded by Bonnie Warren, and after a full discussion, there was a unanimous favorable vote to approve the Claims Docket and Financial Reports as given.

A suggestion was made to have the picture of Miss Hospitality along with pageant information on rack cards that can be displayed in the Welcome Centers as well. This is something Jennifer Parsons and Matthew Godfrey will begin to work on.

Matthew Godfrey updated the Board on the status of the Downtown Light pole Banner Project. The Board was very pleased with Matthew's work and how it will showcase the variety of businesses in the Hattiesburg area.

### **New Business**

Rick Taylor presented the FYE 2017 Budget Proposal for review and approval for the Board. He noted small changes over the prior year, including an increase in the allocation for Zoo or Civic Special Attraction projects and an increase in marketing, especially internet marketing. He noted the changes in the Logo Shop Sales and Resale Items categories as all Gift Shop inventory was purchased earlier in the year by the Hattiesburg Convention Commission. He noted that all other areas should remain constant. After a full discussion, the motion was made by Sheila Varnado, duly seconded by Frank James, and with unanimous favorable vote of the Board the new budget was approved as presented.
